

PremierOne Credit Union Social Media Blitz- Official Rules

1. NO PURCHASE NECESSARY. Membership is not required to participate in the prize drawing.
2. ELIGIBILITY – Participation is limited to eligible persons who are 18 years or older. By submitting an entry, you agree to be bound by these Official Rules. The Promotion period begins July 20, 2022 and ends July 29, 2022 and applies to entries actually received by the Credit Union during this period. All winners will be notified by the Credit Union. If any prize is unclaimed, an alternate winner will be chosen. Employees, officers, directors of the credit union and immediate family members (spouse, parents, siblings, children and their spouses) and persons living in the same households of each of the above are ineligible.
